The complete cost of all bridal party services will be quoted on the day of your trial run. Prices are subject to change as your attendants may change their styling needs. A non-refundable deposit of **50%** is required at this time. The balance will be processed for all appointments not kept or changed without **14 days notice of cancellation.**
